If your Spending Plan/Application is not submitted by November 16th, 2018 you will NOT be eligible for surplus funding.

Deadline for Follow Up Reports is May 15th, 2019

Should you NOT submit your Follow Up Report and Receipts/Invoices by May 15th, 2019 you will be inadmissible for funding and will be invoiced for the 60% received.
