Zones must submit the **\$200.00 participation fee** to the Federation Office with the Map Grant Application/Spending Plan. Zones receive **\$4,300.00** per Zone,

**If your Spending Plan/Application is not submitted by November 20<sup>th</sup>, 2020 you will NOT be eligible for surplus funding.**

**Due to the Pandemic the 60% will not be allocated upon submission of the Spending Plan rather all funds will be allocated upon submission of the Follow Up Reports and receipts/invoices.**

**Deadline for Follow Up Reports is May 15<sup>th</sup>, 2021**

**Should you NOT submit your Follow Up Report and Receipts/Invoices by May 15<sup>th</sup>, 2021 you will be inadmissible for funding. Should you not adhere to these guidelines your organization will be put on probation the next fiscal year.**
