Each local Association must submit the **\$80.00 participation fee** to the Federation Office with the Map Grant Application/Spending Plan. Associations on probation will not receive funding until the Follow Up Report & receipts/invoices are submitted by the April 30th, 2026 deadline.

ZONE MAP

Zones must submit the **\$200.00 participation fee** to the Federation Office with the Map Grant Application/Spending Plan. Zones receive **\$5,000.00** per Zone.

If your Spending Plan/Application is not submitted by October 15th, 2025 you will NOT be eligible for surplus funding.

60% will be allocated upon submission of the Spending Plan and the balance of 40% will be allocated upon submission of the Follow Up Report and receipts/invoices.

Deadline for Follow Up Reports is April 30th, 2026. Should you NOT submit your Follow Up Report and Receipts/Invoices by April 30th, 2026 you will be inadmissible for funding. Should you not adhere to these guidelines your organization will be put on probation the next fiscal year.
