Old Business

Motion: M/S Kyle Harre/Derek Hlewka that we change our quorum number of members from 8 to 6 including officers of members for any special or general meeting.

Ed Whitehead did the second call for nominations.

Mary Cunningham passed out slips of paper to all of the centres in attendance to write their centres names on. Mary then collected the slips of paper and Alice Gray pulled out Glencairn who wins the \$500 donation given by Strikers.

Shelley Baer mentioned that Colleen Haider of Yorkton won the Proprietor of the Year Award and Allison Hunter accepted for Eastview, they won the Split Centre of the Year Award.

New Business

<u>Bowl Canada National Business</u> – Shelley Baer and Derek Hlewka discussed the changes being made to the National Classified (changed to Bowl Canada Team Cup); Club 55+ (changed to Bowl Canada Cup Club 55); YBC Bantams at Nationals; YBC flags for offences at Nationals and other YBC rules. The details of these discussions will be in the next copy of Nexus.

The centres in attendance decided to cap the Bowl Canada Team Cup to 2 teams from each centre for the first year. This is to be played in Regina at 1 centre with 2 shifts possibly as the teams of 5 players play 4 games each.

The centres in attendance decided to implement the yellow flag rule to all the YBC events held and to look at possibly implementing these rules with Bowl Sask events. You will receive a yellow flag for breaking conduct rules. You can receive 1 yellow flag for each different offence. If you do the same offence twice you get a red flag and are out. If you do 2 different offences, getting 2 yellow flags, on the third offence you will be out. For the YBC Nationals you can bump up to 2 bowlers to the next division to field a team. This must be approved by our YBC Chairperson Derek Hlewka.

Motion: M/S by Derek Hlewka/Ed Whitehead that each zone can send up to 2 Bantam teams to Provincials. **Carried**

Colleen Haider talked about the 8 for 8, Mc Bowl month and Bowling Night in Canada which are all great ideas to increase revenue in your business.

Bowling School – There is full attendance this year. Tom Patterson and Mary Cunningham have opened a separate account for this for easy accountability. We receive map grants from the Bowling Federation to help cover the cost.

Motion: M/S by Kyle Harre/Barb Swan-Wilson that Adam Martin, our web master, is to

receive an honorarium of \$250 from each association, Bowl Sask and SK YBC. **Carried**

Motion: M/S by Chuck Cole/Kyle Harre that the per diems for the coaches going to Nationals will be determined at the discretion of the executive members.

Carried

Mary Cunningham will give a form to each coach to sign stating they have received funds.

We want to send the most qualified coach to Nationals whether it is a proprietor or volunteer. Shirley Bird will look into this to see if there was a motion made years ago pertaining to this.

It was decided by the centres in attendance that we will benefit by changing our meeting dates. We will now have our November Member's Meeting on Saturday March 5 to correspond with YBC Provincials.

Motion: M/S by Colleen Haider/Brian Andersen that Bowl Sask will not charge the Sask YBC for office operations, admin expenses or general expenses and meetings starting for the 2014/2015 fiscal year and to be reviewed yearly.

Carried

Motion: M/S by Ed Whitehead/Kyle Harre that Mary Cunningham shall receive a \$100 increase per month; \$50 from Sask YBC and Bowl Sask each. The monthly wage will be \$500 now. **Carried**

Motion: M/S by Ed Whitehead/Kyle Harre that Bowl Sask will cover all expenses for the President and YBC Chairperson and their spouses for the Semi-Annual Bowl Canada meeting. **Carried**

Treasurer's Report - Jun 14, 2015 - BOWL SASK SEMI-ANNUAL MEETING

The Bowl Sask 2014/15 Financial Report

Balance Sheet

The increase in Term Deposits is due to purchase of a new one for last year's profit and interest earned. Our Bank Balance is low due to the fact that I had to assist the YBC in paying bills which will be explained when I go thru their report. The Accts Receivable and Deferred revenue is itemized in the schedules.

Income Statement

The income will not change for June & July except for an in/out with any Bowl Canada Dues being paid if we collect from the late centers. The decrease in dues is because of the loss of North Battleford, Outlook and Langenburg. Considerable drop for National Classified due to low entries.

Expenses - Increase in Directors expenses due to the location of the meeting in January. Increase in the General Expenses are due to an increase in meetings held this year. Decrease in Club 55+ is because the Triples Team event was held in Regina which has the bulk of the entries which lowers the travel costs and most of the travel is paid out under MAP Grant. Decrease in Bowling Federation Membership is due to an adjustment in how the Membership is calculated for the Bowling Federation. I split the cost according to the percentage of the grants received between the YBC and Club 55+ so this figure will fluctuate each year.

Schedule 1 - Accounts Receivable

Bowling Centers not paid - Shaunavon will be joining, Biggar has been sold and we would like to welcome the new owner - James Amanit, Weyburn has said that they are joining, Kelvington should be joining, Kindersley is up for sale and I think that Maidstone will be renewing - haven't heard directly as Doug was surprised that it wasn't paid. The Pendulum paid last week as did two of the sponsors - Strikers and Sanders (I have some brochures from them - so be sure to pick up one.) The third sponsor - J.D.'s will be paying us. The amount that YBC owes will be paid as soon as I get the cheque from Bowl Canada.

Schedule 2 - Accounts Payable: Visa amount will be paid this month.

Schedule 3 - Deferred Revenue.

The amounts in Deferred Revenue include the outstanding receivables as well as the amounts already paid so I will transfer the Admin Fees and Bowl Sask Dues into the next year. These amount may change.

Schedule 4 - Tournament Expenses & Rebates:

<u>National Classified</u> - We took a huge loss in both this year. Mainly due to a drop in entries so much so that our national rebate from entries was too low to receive our normal amount.

Sask Bowl For Cash - Pretty well the same as last year.

Overall the loss for Bowl Sask events increased by \$1046.00 this year due to National Classified.

Schedule 5 - Club 55+ Events

This is the year that we make money on Club 55+ so it is holding its own. Our MAP amount will increase next year to \$6000.00 so we will be okay there as well.

The amount of expenses for June and July should be in the neighbourhood of \$2200.00 - Bowl Canada Annual Mtg., Book-keeping Expenses and the cost of this week-end. This will leave us with a profit of approximately\$4500.00.

I made an error in locking in our Term Deposits in order to get a better interest rate and so I had to have Bowl Sask loan Sask YBC \$10000.00 which will be paid in October when the term matures. My apologies for the miscalculation on expenses. The Prepaid Account are the sports bags inventory which is several years supply. Visa bills - YBC Nationals.

I will continue on to the Income statement as the rest will be explained there.

Income Statement

There was an increase in income due to grant increases of \$7300.00 and only small decreases elsewhere.

Expense - Increase in General Expenses due to number of mtgs., Directors Expenses as we had two reps at the Bowl Canada Semi-Annual this yearand all of the provinces subsidized Northern Ontario - \$1880.00 for us. We had a decrease in Bowling Federation Membership due to the new calculation formulas. This will drastically increase for next year as we will be receiving a huge grant increase.

Schedule 1 - Capacity Interaction

This is mainly the Provincial Banquet which had a large decrease again this year.

Schedule 2 - Talent ID

This shows the lineage cost for the Provincial which decreased slightly this year.

Schedule 3 - Participation Expenses

The miscellaneous travel pertains to late Travel Claims as my total for MAP has to match what we receive.

Schedule 4 - Excellence Tournament Travel

These amounts vary due to the fact that I need to transfer some of the travel claims to MAP - \$6100.00 this year for provincial travel. YBC flew to Toronto this year so our National Travel increased greatly.

Schedule 5 - Excellence Tournament Expenses

This is the cost for uniforms for the Nationals and per diems for the coaches (no longer get paid meals)

Schedule 5 - MAP Grant Expenses

These, as with Bowl Sask, had to match the exact amount of the Grant so some expenses had to be moved around from other categories. Grant increase was great.

Schedule 6- Account Receivable -All from Bowl Canada - still have over \$9000.00 owed.

<u>Schedule 7 - Accounts Payable</u> - These will be paid as soon as Bowl Canada sends the cheque. They are once again really late - received the info for Chocolate Finalization on Friday - two days ago.

With an estimate of \$3000.00 in additional expenses for June and July, the loss for Sask YBC will be nearly \$15000.00

EXECUTIVE DIRECTORS REPORT BOWL SASK MEETING

June 14th, 2015 – Saskatoon

Good morning and thank you for inviting me to attend your meeting on behalf of the Bowling Federation.

The Federation held their meeting April 11th, 2015. Annual Funding for the 2016/2017 fiscal year was allocated to the member organizations.

At the meeting Shelley raised a question re accessing Police Check information so as to determine if an individual with a criminal charge's confidential information can be communicated so an organization can determine the severity of the charge and render a decision as to the individual's volunteer eligibility. I checked with Sask Sport and this information can be given out to designated Privacy Officers. Thus I contacted all the Member Organizations and the following are Privacy Officers:

Saskatchewan Ten Pin Federation – Blaine Boyle Saskatchewan 5 Pin Bowlers' Association – Dennis Brooks Master Bowlers Association of Saskatchewan – Les Wardrop Bowl Sask – ? Derek Wiewka

Only the above individuals will be able to receive individual criminal record information.

The Exceptional Needs committee held a planning session May 23rd in Rosetown. Thanks to Brian and Penny for hosting us.

As discussed at your last meeting the Exceptional Needs Committee purchased three bowling centre operation manuals from Bowl Alberta. Shelley Baer has one, I have one that I will keep in the office and Shirley Bird has one. We thought we should make the manual our own and pay for printing for at least enough manuals to distribute to all bowling centres in the province.

I received permission from Bowl Alberta to print and distribute the manual utilizing our own logos, etc. A letter was sent to Shelley Baer asking permission to utilize the Bowl Sask name on the manuals. Shirley has gone through the manual and I will let her speak to her thoughts on the manual.

In addition to visitations, learn to bowl clinics, and YBC assistance funding was provided for our Learning Facilitators to upgrade their skills. We believe coaching is a benefit to all our organizations and it has been overwhelming for them to incur all the costs associated with the added courses and modules.

We itemized all the bowling centres we could think of in the Province affiliated and non. We appointed committee members to contact the centres and perform a needs assessment and will follow up with visitations depending on the needs of the community. Some visitations will be individual and some we hope to host a number of communities in a central location. Once we have a schedule we will send out notices as to the locations of visitations. We welcome everyone involved in bowling in the community to attend.

Due to the closing of Lloydminister Lashburn contacted me re affiliating and assistance with implementing leagues, coaching, and registering for at least YBC and S5PBA for September. I emailed Bowl Sask members as well as the Exceptional Needs committee and we will ensure they are ready for next season.

As Marilyn Moon and Barb Swan-Wilson attested to at the last meeting our sport is very complicated. Sherry was overwhelmed with information she received and she has a bowling background. Hopefully we will be able to provide a concise, easy to read manual for her and others in the province. Shirley and I have discussed a calendar that lists all registration dates for membership, tournaments, coaching clinics, meetings etc. on a monthly basis that could be inserted into the manual as well as contain all the Member Organizations operation/tournament manuals.

At the Sask Sport AGM yesterday we had a session on New Canadians. It was very informative and if time allows I would like to invite Laura Strong from the Regina Open Door Society to speak at your meeting in November. Her presentation was 45 minutes and it would be productive and educational to allow for a Q & A period afterwards.

In conclusion I would like to thank all the proprietors & managers who organize and implement YBC, 55 Plus as well as assist all of our Member Organizations in their operation of their leagues, tournaments, coaching clinics and fundraisers.

I look forward to working with all of you and if you have questions or would like information about our initiatives, programs and services.
