Bev Manwaring reported on the Winter Games 2026 in Meadow Lake, Sk.

- Bev and Shelley Baer travelled to Meadow Lake to speak with the Bowling Proprietors about how the Bowling events have ran in the past Winter Games. They toured the Bowling Centre and explained what conditions the lanes should be in for the Games and what requirements the Centre would need to have available during the Games. (such as food, gathering space for teams, etc.)

The Youth Trios North/South Events were completed this past weekend. Our new e-transfer system has been working great to get expenses paid, such as bowlers mileage.

## Financial Report and Year-End Motions:

Audited Financials were emailed out along with the notice of this Special Zoom Meeting to the members who had attended the Bowl Sask and Sask YBC AGM on September 20, 2025.

- Jan Cunningham reported that the Bowl Sask's 2024-2025 surplus was more than anticipated, due to additional funding received from Bowling Federation at the end of the bowling year.
- The Sask YBC's 2024-2025 financial stabilization plan was extremely successful, with a surplus. At the September 2025 AGM, there was a request for Sask YBC to once again distribute the 5% provincial Chocolate Rebate to the YBC Centres; it seems this request can be reasonably accommodated. Jan did note that, although this surplus is large, expenditures vary significantly in years when the Nationals are held at a location that requires flying instead of driving. So, in the years where Athletes can drive to the Nationals, those savings are needed to cover the expenses for future Nationals that are more expensive.

2024-2025 Audited Financial Statement for Bowl Sask was presented.

Our newest Fundraiser for our Sask YBC, Chase the Ace is taking off. We have 3 weekly draws completed at Nortown Lanes and no Ace of Spades has been drawn yet. People are starting to like and share the social media posts to help get the word out of our fundraiser.

The Bowl Sask Executive will be reviewing the Bowl Sask Manual and Bylaws and making notes of any changes to bring forward at the Semi-Annual Meeting in May/June 2026.
