New Business

Colleen Haider updated us on the items that were passed at the Bowl Canada Semi Annual Meeting.

- Knockdown Cancer Campaign will be discontinued
- Club 55 registration fee will be \$3.00

- Opening and Closing ceremonies for the YBC Nationals will be held in the hosting bowling centres in Calgary; bowlers must wear team attire
- Coaches at Nationals require police checks and are good for 2 years
- Dress code requirement that pants be worn for Opening and Closing Ceremonies has been removed as bowlers will be in their bowling uniform; dress shorts or skorts
- That we accept Purdy's Chocolatier proposal offering the 24 pack case of \$5 bars for the next 2 years
- YBC National Fund prize incentive be discontinued for 2016-17
- YBC National Fund Profit be revised as follows:
- Bowl Canada retain \$30,000 off the top to maintain contributions to:
- YBC printing \$10,000
- YBC awards \$10,000
- Annual Conference \$10,000

The remaining funds to be divided as follows (% based on net sales):

League rebate 18%

Provincial rebate 28.8%

National YBC 11.2%

That Bowl Canada's portion of the National Fund distribution breakdown be allocated as follows:

National YBC 5.75

Bowling Awareness and Promotion 3.2

Marketing Fund 2.20

New Chocolate campaign – in Colleen Haiders' update

Canada Cup Tourny – Colleen Haider explained she puts all of her bowlers in and the top half qualify to bowl in the roll offs; she charges \$25/team plus lineage. Derek Hlewka charges \$17/bowler. They both make money during the qualifying round from the bar/food/confectionary sales. Some centres think the cost of purchasing a second team should be lower which would give more incentive to have more teams participate.

YBC Nationals – dress code, opening & closing ceremonies – in Colleen Haiders' update Yellow card infractions – A YBC bowler can receive a card for swearing, bad behavior, lofting the balls, etc. If the bowler gets 2 cards for the same infractions, they can get disqualified.

YBC Provincials – Let us know of any changes you would like to see during the banquet or with the national uniforms.

Cost sharing implemented between provinces – in Kyle Harres' report **Incentive monies** – in Colleen Haiders' update

Bowl Sask for Cash Tournament – Randy Ostlund talked about maybe this tournament needs to be revamped; the same bowlers are coming out and it is not expanding. Possibly making it a handicapped tournament (POA) and dropping the entry fees; we don't do enough to promote the sport to the average bowler. **Please bring any ideas you have about this tournament to the June meeting.**

2016 Bowl Sask President's Report March 5th-Saskatoon

Greetings All. I want to thank you all for being here. As you know we have never held this particular meeting this late before and there is lots to talk about. Bowl Canada is taking giant leaps in changing not only the structure of the programs but the face of our associations as a whole. It is so important for us on this executive to be proactive in communicating these changes to our members. No longer getting the vote does not mean we can't actively talk about Saskatchewan's wants and needs. I have been on this executive for several years now. In my opinion and my opinion only, I feel we went from not being able to get any changes done in a timely manner, to actually maybe making too many changes in such a short period.

We are fortunate to have a national executive member Colleen Haider and past president Kyle Harre here today. I look forward to hearing their perspective on the semi annual meetings we just attended in January. Derek was unable to attend so Kyle was our representative at the YBC meetings. He gave our executive a report after he returned and I have asked him to give a brief summary to all of us.

Lets talk about what's new and exciting! 1st - The Bowl Canada Cup tournament. As of right now it has surpassed the revenues generated with our old national classified and it has just begun. Unfortunately there is still a lot of proprietors that have chosen to not run it or more likely have not understood how to run it. I have heard some great testimonials on how successful proprietors have been in generating revenues. Between the lineage and the food & beverages it has been a hit for some! This is something we have not seen with the national classified for years. This new format actually pays for itself. Not only that, the people get to pick their own teams, bowl with their friends, their

families, their own teams! How exciting this provincial will be. 2nd- Club 55 national competition is now a 4 player mixed format. This national will be combined with the Canada Cup and the 10 pin World Cup for one BIG National.

Club 55 has taken on some challenges in regards to what to do for this program to make it more successful. I would encourage all proprietors to come forward with suggestions if you have any great things that work that you would like to share. We are somewhat at a loss on how to get it to grow. The registration price has been increased for this upcoming year which also means there may be some funds available.

In closing I want you to know any recommends we have coming from this meeting will have to be submitted ahead to the executive to review. I would love to send our ideas forward. Lets have some great discussions!

The following details how the new Travel Equalization system will work.

Subject to approval by the Board of Directors.



MECHANICS of System:

- First Instalment of National Fund Rebates will see provinces charged the budgeted avg seat cost (Yellow) x the number of bowlers & coaches (Green) in their contingent and reimbursed for the actual budgetet seat cost (Blue).....

 Chocolate Rebate Green box + Blue box
- Immediately following the Provincial Finals, provinces to ensure YBC has provincial results so rates can be updated based on actual gateway seats used with adjustments (plus or minus) being made to the next Chocolate Rebate issued.
- YBC to then advise provinces of subsidies available per gateway. Provinces to advise their parents of maximum subsidy they are eligible for.
- Ticket purchaser to provide receipts to National YBC in order to be eligible for subsidy provided.
- Where actual seat cost is lower than budgeted subsidy, only the actual cost (per receipts) will be provided.
- Where actual seat cost is higher than budgeted subsidy, only the budgeted subsidy will be provided and parent assumes the difference.

Considerations:

- For those who choose to drive, subsidy will be provided based on 30 cents per KM from home town to Host city, so long as it does not exceed cost of budgeted base airfare (no tax or service fees included)
- Provinces may block space for the contingent, but parents to have final say in arrangements
- Parental control relieves Provincial and National YBC from legal obligations and responsibility... therefore, provinces cannot require bowlers to travel with contingent

Result:

- With all provinces paying the same amount (average cost) per seat, the system becomes fairer and more affordable for all
- Provinces are not affected financially by a hosting schedule and can plan their budgets more effectively and consistently year over year
- National YBC is not required to rotate the event to less than ideal locations due to provincial finances
- National YBC has the ability to select hosting locations based on hosting ability and logistics without adversely affecting provincial budgets



Treasurer's Report - Mar 5, 2016 - Members Meeting

BOWL SASK

I have attempted to estimate expenses but with two new tournaments my figures could be out considerably.

Balance Sheet: I have managed to replenish our term deposits - had to have YBC borrow until their Term Deposits matured - I will be using flex terms from now on so I can take out portions at any time. The Terms were increased by the amount of our profit from last year. Prepaid expenses include the exchange pins we have on hand. Accts. Receivable is so high because I have billed everyone for the 2016/17 season. This also accounts for the deferred revenue amount and the high GST Payable. Accounts payable is \$813.00 in Prov Membership owed to YBC and \$93. in Direct Affiliation - still waiting on list of bowlers from two centers.

Income Statement: The Bowl Canada Cup will probably only see \$210.00 for the Club 55 portion as we did not have enough entries to get a rebate if my calculations are correct. Club 55 has 21 - 4-member teams entered and Bowl Canada Cup has 16 5-Pin teams and 4 10-pln teams. So I just realized that I forgot to include the expenses for Linea for the 10-Pin teams which will add another \$360.00 to the cost. This makes the lineage total \$1500.00 not \$1150.00 Strangely enough this is the same amount that it cost us for National Classified last year. For the Bowl Canada Cup Club 55 we will be fine as Club 55 receives the MAP Funds and that offsets all of the travel and lineage for this event with only 21 teams instead of the usual 40 - 3 player teams.

So barring any great errors in my calculations we should clear \$2300.00. One concern that I have is the drop in non-affiliated bowlers - I do not feel that they are being recorded properly and we need to address this as our grants thru the Federation depend on numbers.

SASK YBC

Balance Sheet: I cashed in both \$10000.00 terms as I wasn't certain when I was going to receive the Chocolate Funds and I knew that we were to pay the mileage for the Nationals this week-end. I am happy to report that I deposited another \$44000.00 on Thursday so we are covered for all the expenses. The Terms that are listed on the Balance sheet are a \$10,000.00 one in the Royal Bank that secures our Visa and \$1900.00 which is the Bowling School profit from last year. Accts Receivable includes the \$813.00 from Bowl Sask and the \$5000.00 balance owing from MAP which we receive once all of the claims are sent in. Prepaid accounts are a supply of bowling bags for the National Contingents and a deposit on the Banquet hall for this week-end. Accounts Payable is very high as it includes Zone Singles and Team Travel as well as the Chocolate Rebates for the centers. Once everyone has sent me their Provincial Travel Claims I will send one cheque to cover all of the chocolate rebates plus travel claims less any charges for Composite Teams and less any charges for National Assessment (\$50.00 per bowler). I include an itemized statement with the cheque so they know the breakdown.

Income Statement: This year our grants total \$55000.00 with Club 55, the Bowling School and YBC. I would like to take this opportunity to thank Rhonda Kurbis for her diligence in getting us the maximum she can, we would not survive without them. Sask Sport would like to have all of the organizations have enough in savings to last a year - unfortunately with the change to National Travel we will be some years in recovering what we have lost. You will notice that paying mileage for the National in Calgary it only cost us \$12285.00 compared to the almost \$38000.00 for last year but the National has tacked on \$6000.00 due to the pro-rated expenses. Next year we will probably receive an extra \$6000.00 as the National is in Ottawa. The year it is going to cost us is in 2013 when we host as we will be assessed an extra \$14000.00 for the pro-rating and that is the year we would usually have been able to save a bunch. Hopefully we will profit \$10000.00 this year.
